

INVITATION TO SUBMIT APPLICATIONS

The Department of Public and Community Health of the School of Public Health at the University of Western Attica is organizing and will operate from the academic year 2023-2024 a Postgraduate Program (Masters) titled:

"Environmental Health and Communication in General and Special Education and Training."

The establishment of the Masters Program (Official Gazette 2495/20-5-2022), and the study regulations (Official Gazette 3158/22-6-2022) are in accordance with the provisions of Law 4485/2017 and Law 4957/2022, as applicable. The program meets the criteria and requirements according to the existing institutional framework for Special Education (Official Gazette 6772/1-12-2023).

General Information

The Masters Program in "Environmental Health and Communication in General and Special Education and Training" aims to further promote scientific knowledge, develop research, and provide high-level specialization in theoretical and applied areas concerning both the promotion of responsible environmental behavior and health, as well as issues related to Special Education and Inclusive Pedagogy in Greece or abroad. Specifically, it aims to equip postgraduate students with critical evaluation skills regarding environmental and special education issues. These skills are undoubtedly essential for enhancing the educational process in both general and special education environments, as well as within the community at large.

The courses are conducted through distance learning modalities and, where deemed appropriate, face-to-face sessions. The duration of the studies leading to the award of the Master's Degree is three (3) academic semesters, structured into two (2) semesters of coursework, each semester corresponding to 30 European Credit Transfer and Accumulation System (ECTS) credits, and one semester dedicated to the writing of a Master's thesis (30 ECTS). A total of ninety (90) ECTS credits are required to obtain the Master's Degree. The minimum duration to complete the degree requirements is three (3) academic semesters. Classes are held on all days of the week to accommodate postgraduate students who are also working professionals.

Eligibility



Admission is open to holders of university or technological sector degrees from domestic higher education institutions, as well as equivalent degrees recognized by DOATAP from foreign institutions. A prerequisite for all applicants is at least a B2 level of English proficiency, which must be certified by submitting relevant documents according to the Special Annex (A2) of language proficiency proof by ASEP dated 14/1/2022.

Application Process & Timeline

Interested candidates can submit their application online, along with the required documents, from April 1 to June 30, 2025, via the form available on the program's website: Environmental Health and Communication.

Final year students are eligible to apply provided that they submit a graduation certificate or a copy of their degree by the start of the first semester. Interviews of candidates will be scheduled and communicated via electronic means.
